Kretzinger moved Zinnel seconded motion to approve the hiring of Jacob Schleisman, Seasonal Park Aide at \$11.50 per hour effective May 16, 2021. NO: None; YES: Duffy, Zinnel & Kretzinger. Motion carried.

Zinnel moved Kretzinger seconded motion to approve of Class C Liquor License, Catering Privilege, Outdoor Service Area & Sunday Sales for Christian's Events LLC. NO: None; YES: Duffy, Zinnel & Kretzinger. Motion carried.

Kretzinger moved Zinnel seconded motion to accept low bid for Drainage Repairs for Drainage District #227 from Jet Drain Services for \$1,000, other bid Behle Inc for \$1,232.20. NO: None; YES: Duffy, Zinnel & Kretzinger. Motion carried.
