At 8:30 a.m. Judge Flynn swore in newly-elected and re-elected officials, Gregg Elsberry, Sheriff; Diane Patrick, Auditor; Bill Zinnel and Erich Kretzinger, Board of Supervisors; Katie Moran, Deputy Auditor.

Duffy called the meeting to order at 9:00 a.m. with all members present. Zinnel moved Behn seconded the motion to approve December 23<sup>rd</sup>, 2020 minutes. NO: None; YES: Duffy, Zinnel and Behn. Motion carried.

Behn moved Zinnel seconded motion to approve the agenda as posted. NO: None; YES: Duffy, Zinnel and Behn. Motion carried.

Zinnel moved Behn seconded motion to approve and sign the Certificate of Appointment of Kaitlynn Moran as First Deputy Auditor, effective January 1, 2021. NO: None; YES: Duffy, Zinnel and Behn. Motion carried.

**RESOLUTION 2020-30**

**WHEREAS**, the Board of Supervisors, hereafter referred to as "the Board", believes the Granular Surfacing of Roadway, hereafter referred to as "the project" is in the best interest of Boone County, Iowa, and the residents thereof. The project is defined as Granular Surfacing of Roads on the FM System; and **WHEREAS**, the Board has sought appropriate professional guidance for the concept and planning for the project and followed the steps as required by the Code of Iowa for notifications, hearings, and bidding/letting; and **WHEREAS**, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Boone County

and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa; and **IT IS THEREFORE RESOLVED** by Board to accept the bid from Peterson Contractors Inc. in the amount of \$814,577.20 and awards the associated contract(s) to the same; **BE IT FURTHER RESOLVED** that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of The Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law; and **BE IT FURTHER RESOLVED** by the Board of Supervisors of Boone County, Iowa, that after receiving the necessary contract documents, including but not limited to, the contractor's bond and certificate of insurance, Scott H. Kruse, P.E., the County Engineer for Boone County, Iowa, be and is hereby designated, authorized, and empowered on behalf of the Board of Supervisors of said County to execute the contracts in connection with the afore awarded construction project let through the DOT for this county.

Zinnel moved Behn seconded motion to approve Gary Nystrom to the Boone County Board of Health. NO: None; YES: Duffy, Zinnel and Behn. Motion carried.

Behn moved Zinnel seconded motion to approve the Iowa Department of Transportation Agreement for County Bridge Federal-Aid SWAP Funding for Project No. BROS\_SWAP-C008(83)—SE-08. NO: None; YES: Duffy, Zinnel and Behn. Motion carried.

Stacy Tharp, Human Resources Director, gave a Departmental Update. Zinnel moved Behn seconded motion to consider extending the COVID leave policy for full-time County employees that have tested positive or are awaiting test results through March 31<sup>st</sup>, 2021. John Roosa, Landfill Administrator & Todd Fisher, Foreman, was present for a Bid Opening for Compactor. 5 companies submitted bids- Aljon, Ziegler, Bomag, Brown Trashmaster & Humdinger. Multiple options were presented. They will compare sizes, trade-in values, maintenance agreements, etc and come back to the Board with their recommendation.
