## Notice of Election

### NOTICE OF ELECTION SOUTHEAST WEB- STER-GRAND CSD SPECIAL ELECTION

Notice is hereby given to the qualified electors of the Southeast Webster-Grand Community School District, in the County of Boone, the State of Iowa, that a special election of said district will be held Tuesday, March 1st, 2022, whereas the voters will vote for Public Measure Proposition VS pertaining to the reorganization of the Southeast Webster-Grand Community School District and the Prairie Valley Community School District into a new school district and school corporation to be known as Southeast Valley Community School District effective July 1, 2023 and Public Measure Proposition VT to adopt a Revenue Purpose Statement specifying the use of revenues the Southeast Valley Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund, beginning July 1, 2023. Precinct Count will be used for the election. Public testing of the precinct count equipment will begin at 9:00 a.m. on February 22, 2022 and will continue until finished at the Boone County Courthouse in the 4<sup>th</sup> floor conference room.

The polls will open at 7:00 AM and will close at 8:00 PM on said day. The polling place will be as follows:  
RP5 and RP6: Pilot Mound Community Center  
112 Pilot Street – Pilot Mound

Pre-registered voters are required to provide an approved form of identification at the polling place before

receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by noon on March 7th. Election Day Registration attestations must provide an approved form of identification. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the county auditor's office at 515-433-0502.

The Boone County Auditor's Office is now accepting Absentee Ballot Requests for mailing. Ballots will be mailed beginning February 9<sup>th</sup>, 2022. Requests for Absentee Ballots to be mailed must be received in the Auditor's Office by 5:00 PM on February 14<sup>th</sup>, 2022 in order for a ballot to be mailed.

In person Absentee voting begins in the Auditor's Office on February 9<sup>th</sup>, 2022 and continues through February 28<sup>th</sup>, 2022 at 5:00 PM.
